Subject: Lead and Copper Rule – System Materials Inventory and 2023 Testing

Board Members:

Almost all of the EGLE required lead and copper samples have been completed for the 2023 testing period. We are working with the remaining communities that have outstanding locations to sample to get the sampling completed. We are working on the EGLE reporting for each community. To date, no communities have had lead results over the 15 ppb action level.

We did have a sampling issue with water quality parameters testing for one location in Birmingham. Our lab technician obtained a sample from a location in the Whole Foods location in Birmingham that was being routinely used. As a result, an extremely low level of phosphate was recorded. Under the new EGLE rules, we should have resampled this location to verify that an acceptable phosphate level was achieved. Our lab technician did not do that. As a result, EGLE has informed Birmingham that they will receive a violation notice, which must be communicated to their residents, and do additional lead testing for two consecutive six-month monitoring periods. We believe that this is an extreme overreaction by EGLE to one test location having one bad parameter. We are working with Birmingham, their attorney and Mr. Davis to prepare an appeal to EGLE. Our lab technician has been reinstructed regarding the requirements for resampling if a bad sample result is obtained.

HRC is working with Berkley, Bingham Farms, Birmingham, Beverly Hills, and Southfield with the preparation of their CDSMI. If other communities are interested in using the services of HRC, please work directly with Brad Shepler to set up an agreement between HRC and your community for the appropriate level of service required.

Subject: GLWA Issues

Board Members:

This report is intended to update the Board on the issues regarding GLWA and the Highland Park unpaid bill issue that have been discussed at recent Board meetings.

Highland Park Cases

There have been no new developments in the Highland Park cases. The stays of the various court actions continue until October 1, 2023. It appears that settlement discussions are ongoing between GLWA, Highland Park and the state of Michigan. It appears that GLWA's General Counsel will be leaving GLWA. We will work with the new General Counsel to indicate our interest in the Highland Park cases. Mr. Davis is continuing to follow any developments in these cases with GLWA's outside counsel.

GLWA has not yet announced when the bill credits resulting from the incremental \$1 million payment from Highland Park will be applied. SOCWA's plan to issue corresponding bill credits, which total only \$8,200, to our customers is on hold until the GLWA bill credits are issued. It is unclear if GLWA plans to issue any additional bill credits for additional payments from Highland Park.

Main Break on 120" Water Main

SOCWA withheld \$44,984.91 from our GLWA payment that was due on June 9, 2023. This amount has been segregated in a separate account at Flagstar. GLWA denied our initial claim for payment, but they have not responded to our withheld payment. GLWA's outgoing General Counsel has verbally proposed a settlement in this matter. Mr. Davis and I will be following up to complete a settlement during September.

GLWA Contract Reopener

We will be meeting with GLWA during September to discuss the maximum day and peak hour values in our water purchase contract. We are reviewing our operating results for this summer in order to present our case to GLWA. SOCWA's maximum day this year was June 5 when we purchased 46.22 mgd from GLWA compared with our current contract limit of 60.5 mgd.

Subject: T-12 Parking Lease Amendment

Board Members:

SOCWA currently leases a portion of our property located on 12 Mile just west of Telegraph to T-12 Office LLC, the owner of the old Comerica building on Telegraph just north of 12 Mile. When this lease was originated, T-12 thought that they might be required to install additional parking by the City of Southfield. That requirement did not develop, so nothing was done with the leased property, but we still receive monthly lease income.

T-12 is redeveloping their property again and they have requested that we double the square footage being leased from SOCWA in order to develop parking that they believe will be required for their new property uses. T-12 believes that this time they will be paving a portion of our property. We have discussed amending the existing lease to encompass the additional square footage with a commensurate increase in our lease revenue. We are awaiting a draft lease amendment from T-12 that can be reviewed with the Board.

The existing lease allows SOCWA to cancel the lease for any reason with two years' notice and requires that any paving on the site be reviewed and approved by SOCWA.

Subject: Webster Water Main Leak

Board Members:

In the evening of Monday, August 14, SOCWA experienced a large water main leak on Webster Road right in front of our administrative office. Our on-duty operator noticed sudden, large decreases in the two pressure sensors used to monitor the water system near our office and called in all available personnel. The leak location was obvious as a large amount of water was observed filling the streets in Berkley near our office. The responding SOCWA personnel were able to quickly isolate the leak location while maintaining supply to the remainder of the SOCWA system. Adequate pressures were maintained at all community meters during this period so there was no need for a boil water advisory.

Our contractor excavated the leak location on August 15 and determined that a 12" cap on a tee on a 12" line between our 30" concrete main and an emergency connection to Berkley had blown off the main due to corroded bolts. The repair was simply to install a new cap on the tee. In addition, all other bolts exposed in the excavation were replaced. The SOCWA main was returned to normal service following the completion of the appropriate water testing. We are waiting for the contractor to replace the pavement that was removed during the excavation for the repair.

I was very pleased with the responsiveness and performance of the SOCWA staff during this event. We were also assisted by the Berkley DPW staff, who were of great help with traffic control and barricade placement while the main was leaking.

We did have two minor property damage claims that resulted from water entering residents' basements. We are working with Mr. Davis to evaluate those claims.
